**Show Requirements:**

All pigs must be sired by boars in stud at Hi Point Genetics Inc. or Kilmer Swine Farm Inc. through semen sales or produced from bred gilts purchased from Hi Point Genetics Inc. It is recommended that all pigs weigh between 40 – 80 pounds body weight.

**NEW RULE** Each breed will show by *Gilt* prospect, *Barrow* prospect, and *Boar* prospect divisions. There will be six divisions: Duroc, Hampshire, Yorkshire, Crossbred, White AOB and Dark AOB. We prefer that pigs be born after December 15, 2009 except for purebred gilts that are eligible for the National Junior Summer Spectacular. Gilts for the NJSA show may be farrowed after December 1, 2009. Prospects for the World Pork Expo Junior National must be born after November 1, 2009. All pigs must have standard ear notches.

Remember **\*\* Owners/breeders are responsible for transferring purebred pedigrees.**

Entries not making the sale offering will be the responsibility of the owner. We encourage you to take advantage of the buying crowd on sale day and sell your pigs privately if they are not selected for the sale. Pens will be limited, so please prepare your pigs for small pen accommodations.

**Health Regulation Requirements:**

1. An interstate health certificate of veterinary inspection from the state of origin and issued by a licensed accredited veterinarian must accompany each animal. All animals may be listed on one health certificate. **THE ORIGINAL HEALTH CERTIFICATE MUST ACCOMPANY SHIPMENT AND one PHOTOCOPIES OF THE ORIGINAL CERTIFICATE MUST BE SUPPLIED FOR EACH ANIMAL.** Each certificate must show the name and address of the consignor and be consigned to the Hi Point Genetics, Inc. Customer Appreciation Sales and the individual identification of the animal is required (ear notches are acceptable for purebred animals but federal approved ear tags are required for all crossbred animals. No health certificate needs prior state approval but you **MUST** use the **sale permit number (A100327 )**
2. Since all states are now STAGE 5 of the Pseudorabies (PRV) eradication program, no testing is required for this show. If the animal comes from a Pseudorabies qualified herd and from a Brucellosis validated herd, it is required that these numbers and the last test dates do appear clearly on the health certificates.
3. All health certificates must carry a statement that the farm of origin of the swine has not had pseudorabies or swine dysentery in the past 12 months, has not had TGE in the past 60 days, feeds no garbage, and is not under quarantine for any disease condition and uses no pseudorabies vaccine.
4. It is suggested that all pigs be vaccinated for circovirus, erysipelas, swine flu and mycoplasma. Two injections given at least two weeks apart is preferred. This product is available commercially from several vaccine companies. This is not a sale requirement.
5. **REMEMBER, EACH PIG MUST HAVE 2 COPIES OF INDIVIDUAL HEALTH PAPERS**
6. The state of Oklahoma requires that all pigs entering OK must originate from a validated herd or be Pseudo tested. The State of Utah requires a test for PRSS, No animal from this sale may enter the State of Utah.

**Entry Fee and Commission:**

The entry fee is \$20 per head on **Gilts** and **Barrows** and \$50 per head on **Boars** and **must be postmarked by March 20, 2010.** **FEES MUST ACCOMPANY ENTRIES.** All late entry fees will be double. Please remember all entries must be checked in by 8 a.m. on Saturday, March 27, 2010. All entry fees are non-refundable. A commission fee of 10% will be charged on all pigs sold. Proceeds from the sale will be mailed to the seller within 30 days of the sale date. In case of insufficient funds and/or nonpayment by the buyer, settlement with the seller will be delayed until collection is secured.
